### Item 8.01 Other Events.

On January 11, 2021, Super League Gaming, Inc., a Delaware corporation (the 'Company'), entered into securities purchase agreements with a limited number of institutional investors for the registered direct offering of an aggregate of 3,076,924 shares of the Company's common stock, par value \$0.001 per share (the "Shares"), at a purchase price of \$2.60 per Share (the "Registered Direct Offering"). The Registered Direct Offering closed on January 13, 2021, and resulted in gross proceeds to the Company of \$8.0 million.

The Shares were offered by the Company pursuant to an effective shelf registration statement on Form S-3, which was originally filed with the Securities and Exchange Commission on April 10, 2020 (File No. 333-237626). The Company filed a final prospectus supplement in connection with the Registered Direct Offering on January 12, 2021.

In connection with the Registered Direct Offering, the Company is filing the opinion and consent of its counsel, Disclosure Law Group, a Professional Corporation, regarding the validity of the securities being registered as Exhibits 5.1 and 23.1, respectively, hereto.

On January 12, 2021, the Company issued a press release announcing the Registered Direct Offering. A copy of the press release is attached as Exhibit 99.1 hereto.

# SUPER LEAGUE GAMING ANNOUNCES \$8.0 MILLION SALE OF COMMON STOCK

SANTA MONICA, Calif., January 12, 2021 -- Super League Gaming (Super League or the Company) (Nasdaq: SLGG), a global leader in competitive video gaming and esports entertainment for everyday players, today announced the sale of 3,076,924 shares of its common stock at a price of \$2.60 per share. Gross proceeds from the offering, before expenses, are expected to be approximately \$8.0 million.

Super League currently intends to use the net proceeds from the offering for working capital and general corporate purposes, including sales and marketing activities, product development and capital expenditures.

The transaction is expected to close on or about January 13, 2021, subject to customary closing conditions.

The offering is being made pursuant to an effective registration statement on Form S-3 (File No. 333-237626), previously filed with the U.S. Securities and Exchange Commission (SEC) on April 10, 2020 and declared effective on April 20, 2020. The securities may be offered only by means of a prospectus supplement and accompanying prospectus that form a part of the registration statement. A preliminary prospectus supplement relating to the offering will be filed with the SEC and will be available on the SEC's website at <a href="https://www.sec.gov">www.sec.gov</a>.
